Dairy Farm Environmental Sustainability Award

This award recognises the dairy farming business which demonstrates in a practical way choices that have been made on farm for the long term sustainability of the environment. Considerations will be made around the wise use of the land, labour & capital resources available or created. Increasingly the effects of dairy farming on both surface & groundwater and its impact on soil properties are factors the judges will consider.

Judging criteria – please submit with this form a maximum of 2 pages, detailing how you have met, or are working towards the following criteria:

1. adoption of sustainable land and water management practices, and/or are implementing an EMS (Environmental Management System)
2. maintenance of and/or improved productivity and environmental condition of your property as demonstrated by changes in key indicators such as: a reduction in the environmental cost of your product (e.g. improved water use per hectare or litre of milk) and improved farm business results; a change (%) in soil carbon or soil organic matter; a reduction of greenhouse gas emissions (e.g. through lower fuel or fertiliser use or improved stock management); increase in biodiversity, above and below the soil; reduced soil erosion etc
3. creation of a property management plan, reflecting how your management and practices both improve productivity and improve or protect natural resources, with

links to neighbours, landcare or catchment management plans. Please include a copy of your plan if possible.

4. merging of your landcare practices within your commercial farming operation (e.g. your farming is consistent with how you manage biodiversity, shelter belts, re-vegetated areas and soil and water conservation) and demonstrates no loss of income or may even show an economic gain
5. management of non grazed or uncropped areas (such as creeks, hills, dams, wetlands, unimproved pasture, native remnant vegetation) and how you manage them for conservation and biodiversity benefits within the farm system
6. co-operation with and encouragement of others to become involved in sustainable environmental management practices (e.g. with neighbours, other landholders & local authorities, by participating in field days, workshops etc).

Dairy Farm Innovation Award

This award recognises the dairy farming business which has used innovative measures for problem solving in the farm business or has been innovative in the approach to technology used to assist the business. There is a need for the innovation award to be recognised as part of a long-term sustainable contribution to the business and the environment.

Judging criteria – please submit with this form a maximum of 2 pages, detailing how you have met, or are working towards the following criteria:

1. Identification of appropriate innovative management/technological practices
2. Implementation of innovative measures
3. Maintenance of and assessment of implemented innovative measures
4. Creation of a property management plan, reflecting how the innovative measures will/have impacted on the management of your dairy business. Please include a copy of your plan if possible.
